Deposit and Payments

- An initial deposit is required to secure the amount specified in the estimate and the booking date of the wedding. The deposit applies to the wedding order, but is not refundable. If the wedding is cancelled, the deposit is forfeited and cannot be applied to any other purchase.
- 2. Deposits apply to the wedding order as quoted in the most recent estimate.
- 3. You may make payments on the balance at any time. We do require that the wedding be paid in full one week prior to the wedding date.
- 4. By signing this contract, you confirm that you accept all charges detailed in this agreement.

Delivery

- 1. Personal flowers, such as bouquets, boutonnieres, corsages, and ceremony decorations are usually delivered two hours prior to the ceremony start time. All boutonnieres and corsages will have a name tag attached, to identify to who they are for.
- 2. Reception centerpieces and decor are delivered approximately two hours before the start time of the reception. This does, however, depend upon the time and convenience of the venue/caterer.

- 3. All details will be final at the time the final bill is paid, at least one week prior to the wedding.
- 4. Any changes to the Wedding Plan must be agreed upon by both parties and any additions will be billed in addition to the most recent estimate.

Additional Terms

- 1. Oviedo Florist reserves the right to cancel/void this contract if at any time we feel the obligations cannot be met.
- 2. Where specific varieties of flowers or colors are defined, Oviedo Florist reserves the right to make substitutions of flowers of equal value with the client's approval. This may become necessary due to market conditions and availability.
- 3. Our staff is contracted to do the work explicitly detailed in this agreement and will work under a strict time schedule to complete the job. Any further day-of tasks at the event, including but not limited to helping set up non-floral decor, lighting candles, arranging archways, or other requested activity requiring our time that was not previously discussed and listed in the Wedding Plan is subject to additional fees based on our hourly rates.
- 4. In the event of fire, natural disaster (i.e. hurricanes), or emergencies, liability is limited to full refund of all monies paid.
- 5. In the event the wedding is cancelled:
 - a) up to two months in advance, all monies (excluding the initial deposit) will be refunded
 - b) less than two months in advance, our ability to refund will be dependent on supplies, products, and items purchased or ordered that cannot be returned or cancelled
